Members are bound by the Constitution and Bylaws in force at the date of their acceptance into the Club; the Constitution and Bylaws may be amended from time to time.

APPLICATION GUIDELINES

Application Requirements / Checklist

- Applicant must be 19+ years of age (16 years if applying for Intermediate Membership)
- Applicant and spouse must provide a photocopy of government-issued photo ID (for example, driver's license or passport)
- Two sponsors *
- I have read the <u>Constitution and Bylaws</u> of West Vancouver Yacht Club.

Sponsor Criteria

An applicant must have two sponsors who are currently
West Vancouver Yacht Club Members

* In the case of an applicant not having two sponsors who are WVYC Members, two letters of reference from the following sources must be attached: president or general manager of an existing or recent private club affiliation, a business associate (supervisory), a clergy person, or a professional designation, such as Engineer, Doctor, CA, CGA, CMA, CPA or more.

- A Member acting as a sponsor must meet the following criteria:
 - Be an Active, Associate, Honorary Life or Senior Member of good standing for at least the past 12 months
 - Be at least twenty-seven (27) years of age
 - Have known the applicant for at least two years
 - Can speak reliably on the applicant's character and their suitability to be a Member
 - Sponsor should not be a family member
- All completed sponsor forms (or reference letters if applicable) must be submitted in confidence directly to the Membership Department via email membership@wvyc.ca.

Application Process

Applicants can expect the application process to take up to 30 days or more. Once the application is submitted:

The Board of Directors shall at their next meeting vote upon the application provided that notice of the application has been published or sent to the Members at least seven (7) days in advance of such meeting and further provided that any Director who has proposed or seconded an applicant shall abstain from voting on the election of such applicant.

Important Facts

- All membership application materials are confidential and will not be disclosed to parties outside the application evaluation process and membership administration.
- Applicants are required to interview with a representative/ s from the Membership Committee regardless of having two sponsors (or references) and meeting all the application requirements.
- Applicants are not permitted to use the Club throughout the application process.
- The Club, in its sole discretion, may decline to consider or process any application without providing a reason.
- Any untrue or misleading response or representation provided during the application process is grounds for rejection.
- Club communications and execution of all application documents will be in the English language. Translation services for documents, interviews or other submissions are to be provided by the applicant.

I, _____, hereby apply for membership at West Vancouver Yacht Club on the following terms and conditions:

1. Privileges within the Club will not be available until my application has been approved and I have been admitted to membership. Monthly dues will commence in the month following Membership approval by the Board of Directors.

2. Upon admission to the waiting list or as a Member, West Vancouver Club takes no responsibility for the length of time required to gain admittance as a Member.

3. At the date of this application the entrance fee set by the Board of Directors is \$ ______ (Our current Entrance Fees & ______ Dues are listed on www.wvyc.ca). I understand the entrance fee is subject to GST.

4. For my application to be considered, I understand that a non-refundable deposit will be required. (*This deposit is not less than the greater of \$1,000 or 25% of the total Membership fee payable, plus total taxes due for entrance fees.*) Following submission of the application, WVYC Administration will be in touch to confirm the exact deposit amount required. The deposit will be applied to the entrance fee if my application is approved.

5. Upon admission as a Member I shall do either of the following:

Pay the total entrance fee and pay no further entrance fees when I am admitted to Membership.

Opt to finance the balance of the entrance fees through the Club's installment payment program over 48 months.
